IV. Reports:

- Principal's Report
- Preliminary Quality Review Results look great
 - This report incorporates state data as well as parent and teacher feedback. We did very well.
 - We just had our PPO with deputy superintendent Mariela Graham. We were told that there was no feedback. We are shining as an example within the district.
 - We received 85% response rate for the survey.
- Opportunity to bring in Elevate for Executive Functioning Workshops for Grades 4 and 5.
 - Cost is approximately 375 per workshop
 - These workshops can prepare students for middle school.
 - We find that supporting students in staying organized is currently a significant challenge. A considerable amount of instructional time is spent teaching foundational organizational strategies that many students lack, including time management, overcoming procrastination, building academic stamina, and effective note-taking skills.

- CRSE and Civics For All
 - Shoutout to our teachers for their work on CRSE and Civics for All. All grade levels are responsible for implementing CRSE. This year, students in grades 3 and 5 will engage in civics lessons and participate in Soapbox activities. Additionally, all students in grades 3–5 attended the participatory budget assembly, where they were able to submit suggestions and share their ideas.
- Mathematics Curriculum
 - We have been using Envision math for 5 years.
 - We have concerns regarding the Illustrative Mathematics curriculum.
 - Specifically, there appears to be a significant emphasis on sensemaking and

student interaction with content and skills prior to explicit instruction.

- The YOU DO – WE DO – I DO structure differs substantially from our current instructional model.
- We are questioning whether students will have sufficient time for explicit skill instruction and how long each lesson is intended to take.
- Additionally, we would like to review sample lesson plans to gain a clearer understanding of what the units and daily lessons entail.
- Families are not interested in an online curriculum or more computer time for their child.
- They are concerned about this curriculum working in ICT educational settings.
