- Principal's Report
  - Us News Report
    - PS 84 has been ranked #134 in New York Elementary Schools and #37 in New York City Public Schools Elementary Schools.
  - We have teachers differentiating their instruction to meet the needs of all students.
  - The school also has programs such as Recovery Services, literacy specialists, and committed teachers.
  - The District 3 Superintendent has informed the new literacy program Wit & Wisdom for elementary schools.
  - This new literacy program will require a lot of professional development for teachers to learn this curriculum in addition to the Baccalaureate implementation.
  - We are in the process of taking June 14th for planning in addition to the Chancellor's Day.
  - Class Size Mandate Coming
  - This mandate is coming to New York City, K-3 20 students and 4-5 23 students.

      - To incentivize reading habits and improve reading levels
    - Math Olympiads
      - Improve mathematics skills
  - Handwriting materials ordered

### V. Discussion of Unfinished Business Agenda Items

- CEP Progress monitoring
  - o Data comes from different sources and are reflected on reports
  - o ELA
    - Our major goal is for our students to be at grade reading level. All students in grades 1-5 will increase by 3%. The three literacy goals related to general education, students with disabilities, and English Language Learners were not met by less than 1%.
    - The reading levels benchmark was shared for parents to understand the reading levels per grade.
    - RTI is a team of reading specialists who support those students who need extra support.
    - A possible reason this data has been a little lower is the timing of reading assessments in the upper grades.
    - Teachers use many other literacy assessments such as MAP Growth, Arcadian, exit tickets, pre and post-assessments, reading responses, and writers' celebrations.
    - It is important to understand the role of SLT when making decisions about the CEP Comprehensive Educational Plan.
    - Daily reading is crucial for reading improvement, families must also be held accountable for this important factor of the learning process.
    - Perhaps reading incentives for students to improve their reading habits.

### Special Education

- The goals include improving instructional student management needs. Designing coherent instruction is the data we collect to evaluate the effectiveness of this goal.
- Include parents' voices within a student's Individual Education Plan (IEP) and student voice within a student's IEP.
- We are on track to achieve these goals. The data is taken from random IEP meetings

### Attendance

- For chronic absenteeism, the goal is that attendance for all students will increase by 1%. In December absenteeism increased.
- Strategies to address the different reasons for absenteeism were discussed such as communicating to parents the great impact of extended vacation on school rating, student learning, and overall school performance.

### College Readiness

- College readiness data has not been released.
- Our fifth graders visited Columbia University and were engaged to go to college.
- Maybe having career days or field trips to campuses may impact their college readiness.
- We can also get PS84 alumni to come and talk to students.
- Career days can be a strong project by having family questionnaires with information about their jobs.
- We can have Zoom visits to give tours around their job places.
- Teachers can also use this information to plan units and invite parents to visit the classrooms.

### Supportive Environment Framework (SEF)

- Students are physically and emotionally safe.
- Part of this goal is to have students know that if they need help, they have an adult to contact.
- We would also like to make sure that all students regardless of the age group or how long they have been in school, know who to contact as a person of trust.
- We are above 80% which is great.
